#### **Unfinished Business -**

#### 1. Per Capita Tax Bill

Upon advice of the Borough Solicitor, the Borough Council cannot waive collection of collection fees because the Tax Collector is appointed as the collector of Per Capita Taxes for three taxing bodies, Cambridge Springs Borough, Penncrest School District and Crawford County. The Collection Agency is entitled to recover collection fees and the Taxpayer has an obligation to keep the Tax Collector informed of the correct address for notice of taxes due.

### 2. Public Parking Lot - Spring St./Cummings St.

Council discussed what improvements could be done to the public parking lot on the corner of Spring Street and Cummings Street. Council decided to have the Street Department replace the old wooden poles that separate the parking lot from the former Dairy Mart property and also put a few of the flower boxes along the property line.

## 3. Restroom/Concession Stand at Stein Field

Frank Reichart submitted an estimate of \$2,542.50 to refurbish the interior of the building. The estimate includes demolition, door/plumbing modification and concrete. A motion was made by Viglione to accept the estimate. The motion was seconded by English. A poll vote was taken:
