MINUTES - August 2, 2021

Borough of Cambridge Springs

A regular meeting was held by the Cambridge Springs Borough Council on Monday, August 2, 2021, at 161 Carringer Street. The meeting was called to order by Mayor Randy Gorske at 7:00 p.m. The following members were present: Jennifer Howell, Justin Gaines, Delores Hale, Pat Mahon, Larry Morrow and Brian Harmon. Also present were: Attorney Tim Sennett, Cambridge Township Supervisors Charlie Bauer and Kevin Cole, Township Secretary Debra Merritt, CAJA Board Member Jodie Ellis and Manager/Secretary Sandy Pude.

Representatives from the Authority, Township and Borough asked to have Attorney Sennett present at the meeting to provide information about a recent discussion with Moody's Investors Service. Moody's provides the credit ratings for the Authority. Because the Authority had not met their required 120% debt ratio coverage for 2020, Moody's was reviewing the Guaranty Agreement between the Authority, Borough and Township. It was suggested by Moody's for all three parties to approve an Amendment to that Agreement which adds a section entitled "Declaration of Default Acceleration". In the event of a declaration of default acceleration if CAJA weren't able to make full and prompt payment, the Borough and Cambridge Township would guarantee full and prompt payment according to their pro-rata share amount.

Attorney Sennett said that the Trustee, Bank of New York has not been in contact with the Authority regarding a declaration of default acceleration, it was only Moody's that is reviewing their credit rating. Moody's stated they would not lower the Authority's credit rating if the amendment to the agreement is in place.

Sennett said if the Trustee, The Bank of New York or 15% of the Bond Holders were to authorize a declaration of default acceleration, the Authority would receive a written notice and have 30 days to provide a financial plan.

Attorney Shaddinger provided a memo to the Council stating his recommendation is to approve the amendment provided by Attorney Sennett.
