9. For Discussion - Eliminating the discount on water and garbage bills

At the December 2022 Cambridge Area Joint Authority meeting, a decision was made to eliminate the 2% discount that was given on the sewer billings for Borough and Township customers and the water billing for Township customers.

Pude said that the Borough has a contracted amount that is paid to the garbage collector each month. But because the 2% discount is given, the Borough does not collect enough in garbage fees to cover those costs. Any shortfall is paid with other revenues. The yearly contracted amount is \$294,354 and if everyone paid discount each month there would be a shortfall of \$5,887.00 by the end of the year.

Pude also said if everyone were to pay discount each month on the water billings, the amount lost would be approximately \$8,572.00 for the year.

Council discussed the elimination of the discount on water and garbage billings, but have decided to wait until next fall to make a decision when the 2024 budget is being prepared.
