Administrator Report – A written report was submitted. Pude also said that Canfield Electric submitted an estimate for updating the lighting on the buildings at the Bolard Avenue plant in the amount of \$1,650. This did not include any of the pole lights. Matt said some of the pole lights are starting to burn out. Hale asked if there was a security system in place for the plants. At this time there isn't. Matt said he would contact Canadohta Security to get a quote.

Engineer's Report – Matt downloaded the readings for January from the Riverside flow meter. Because the totals for the month are high again, the question is where is the flow coming from. Is it sewage or are the downspouts tied into the sanitary sewer instead of the storm sewer line, is ground water entering the system somewhere? Matt will contact TECSmith to have the

meter calibrated for accuracy. If it is accurate then we will need to find out where it is coming from.

They are using the water well on the property for the brewing process, so that could also be a factor. Some of the well water may be going into the sewer system when equipment is being rinsed or cleaned.

Also, with the Riverside using the water well Pude will find out if they have installed the backflow preventer which would prevent the well water from entering into the Borough water system. Pude said she thought they had, but would check with the Water Department.

Also discussed was having the Riverside install a meter on the water well. The Authority currently has customers on SR 19 that are on the sewer system but use their private water wells. To charge for sewage, the Authority uses the readings from those meters.

Diane calculated the surcharge for the month of January and it is \$131.30.
