#### 8. Public Comment – limited to agenda items

Residents from Pleasant Hills were in attendance to discus the high water & sewer bills that they received in December. They attended the Borough Council meetings in December to discuss the bills with them. The Council suggested the also attend the CAJA meeting because the Borough only reads the meters and does the billing, they can not give credits or forgiveness because these homes are located in the Township and are CAJA customers.

Gene Woznicki said he has asked Pude to contact the company that manufactures the meters to see if these meters have any known defects and she said she would do that.

Ken Dine said that he has tested a few of the meters and they have tested accurate. He has also talked with some of the homeowners that have had high bills and some that didn't to see if there is anything in common with these homes. Also everyone he has talked with says that the meters only register when water moves through them, they do not speed up when they go bad, they slow down or stop working.

Tim Wheeler asked if there could be any forgiveness with the high bills.

Hale said that CAJA can't forgive these bills because then everyone that gets a high bill would also want forgiveness.

Bauer said that he had a similar problem a number of years ago and since then he reads his meter every month so that if there is a problem it is caught right away. He then has actual

readings each month that he can verify with the next bill he receives. He suggested that the residents read their meters every month for a while then submit that reading for the billing.

Dennis Ottaviani was asked if he has ever heard of water meters running fast and giving false readings. He said that he has worked with water systems for a lot of years and when meters go bad then slow down or quit working altogether.

Bauer said for now the residents should read their meters every month and CAJA and the Borough will continue to gather information on the meters.

Adam Crabtree from the Riverside Brewery said after he attended the last meeting he started doing a lot of research and discussing with other breweries the discharge into the sewer system from the brewing process. He has already started to make some changes to get the numbers down and he is trying to keep as much of the solids out of the system as possible. He said that of course he does not have control over what is put into the system from the kitchen area but he wants to continue working with Matt to get into compliance or to at least get numbers lower so that the monthly surcharge is less.
