1. Consent for Sale of Property - 195 South Main Street

The Borough received a notice from the Crawford County Tax Claim Bureau concerning a bid of \$2,500 from James Byers for the former Iron Horse property located at 195 South Main Street.

James Byers stated that he is now able to move forward with the project to raise the needed funding to restore the structure. He estimates the multi-year project will cost approximately \$250,000. The first issue that he will address is the roof which has partially collapsed. He estimates that portion of the project will cost approximately \$1,500.

Hale asked if he is unable to fix the structure, will he have the funds to tear it down.

Byers said once he purchases the building and if he finds that it can't be repaired, he will be responsible to have it torn down.

Council was in agreement to approve the sale of the property. Mayor Gorske will sign the necessary form giving consent to the County for the sale of the property.
